Helpful Hints

• Even though the STOP card is no longer in use, you should still pause approximately 10 seconds in the direct seat over the skip bid.

- Dummy should NOT play or touch a card until declarer has called for the card.
- To save time, make your opening lead before you write down the contract.

• If an opponent has made an insufficient bid or has made a bid out of turn, the Director should be called since rules have changed.

BALANCING BIDS Part Two

In the December BridgeBits we covered some of the more basic balancing auctions including balancing NT's and the balancing jump shift. Last time, I suggested replacing a strong balancing 2NT (19-21), with a 2-suited alternative.

Bear in mind that after a 1C or 1D opener comes around to you in the balancing (4th) seat, a cue bid of the openers suit shows 5-5 in the majors. This is a Michaels cue bid. Your hand can be strong – up to 16 HCP - and you are forcing partner to choose. When Michaels is used in direct seat it shows the same holding although some partnerships promise only 4 spades. If you have this agreement you can also use this treatment in the balancing seat, but more about that later.

With (AJxxx, KQxxx, xx, x) you would make a Michaels bid in the balancing seat. You would pass any two-level response and let partner decide to compete to the THREE level if the opponents persist. You would never raise to 3 on your own – you have shown your hand! With (AQJxx, KQJxx, xx, x) you certainly would consider competing to the three level, but would not raise to three over partners 2 level response if the opponents pass.

When the auction goes (1C/1D) - P - P - 2NT, balancer likewise shows a two-suiter and most play this as two lowest unbid suits. Responder still adjusts his bids subtracting a King (refer to balancing "rules" discussed in the last BridgeBits). Partner bids the suit for which he has "tolerance." If he has extra values then he can make a jump or cue bid with an even better hand.

With the auction 1C - P - P - (?) 2NT shows diamonds and hearts. You are expected to bid your best fit. This is almost written in stone. There is virtually no holding that you may have in spades that would permit you to bid that suit unless you fell asleep with Q J 10 5 4 3 2 and forgot to make a weak jump shift in second seat. Even then, if your hand were Q J 10 5 4 3 2, 5 2, 5 4 2, 9 you have a clear 3D bid and you should be happy to play in the 5 - 3 fit. Partner could have two spades but he may not. What you have is a third diamond and a certain ruff to help set up his hearts. Playing in spades you can do neither.

With (Qxxx, Axx, 10xx, Kxx) you can bid either red suit but should consider 3D since a diamond ruff is much more likely to occur than a heart ruff. It's a close decision but one you should consider. In terms of points, you value the hand at 6 points (you did remember to subtract a King). If partner bids 3H he is showing a very good hand - bid 4.

Now, the rest of this article is for those who only guarantee 4 spades with a Michaels cue bid. I know there are quite a few who do. However, I start with a caveat that this should only be considered by experienced partnerships.

I suggest making your balancing 2NT promise 5-5 in any of the unbid suits, including the majors. Michaels is still the same for you, but now over a Major opening your balancing 2NT guarantees 5-5 or better. You give up a level of bidding so you imply a better hand. With a weaker 5-5 in the majors it

is best to simply bid Michaels. For example, over 1H - P - P it is better to bid 2H holding Q 10 9 4 2, 3 2, A Q J 3 2, 7, giving partner the chance to bid 2S. With K Q 10 3 2, 3 2, A K J 3 2, 8 you can bid 2NT. Exchange the singleton club for the Ace in the latter example and you should start with a double. If you don't it will be impossible to invite game after partner's likely bid of 3 of a minor. When you have both minors the auction is standard. This alternate treatment has significant advantages and one disadvantage when you give up a level of bidding. Here judgement prevails and you must have better values.
